## **Appendix 1**

### **The Structure of the Organisation**

Under the Constitution the structure of the Friends consists of:

The **Members** – who have the right to attend the annual general meeting (and any special general meeting) and have important powers under the constitution; in particular, the Members elect people to serve on the Management Committee and take decisions in relation to changes to the constitution itself.

The **Management Committee** – which holds regular meetings during the period between annual general meetings, and generally controls and supervises the activities of the Friends. The Management Committee is responsible for monitoring the financial position of the association.

### **The Management Committee**

The Management Committee are the Charity Trustees of the Friends.

The maximum number of members of the Management Committee is seven.

The Chief Executive Officer of The Black Watch Regimental Trust is an ex-officio member of the Management Committee.

A person is not eligible for election/appointment to the Management Committee unless he/she is a Member of the Friends.

At each Annual General Meeting, the Members may elect any Member to be a member of the Management Committee.

The Management Committee may at any time appoint any Member of the Friends as a member of the Management Committee.

At each Annual General Meeting, all members of the Management Committee shall retire from office but shall be eligible for re-election.

The Management Committee members elect from their number a Chair, Treasurer, Secretary, and any other office bearer they consider appropriate. All Office Bearers cease to hold office at the conclusion of each Annual General Meeting but are then eligible for re-election.

## **Appendix 2**

### **Background History for Committee Member Candidates**

#### **Bill Macpherson | Chairman**

Although starting out as an electronics engineer, most of Bill's life was spent in the chemical instrumentation industry providing chromatography, spectroscopy and data handling support, working throughout Africa, Middle East, India, Russia, Eastern Europe and Scandinavia. Now retired, he runs his own company providing bespoke software, Web Hosting and website design. He was an officer in the Black Watch Btn. Army Cadet Force for 12 years, retiring as 'B' Company Commander. Bill has been a volunteer at Balhousie for 10 years and is a member of the Friends Events Committee.

#### **Rosemary Pitcaithly | Secretary**

Rosemary Pitcaithly has been a volunteer at Balhousie for fifteen years, assisting with the Museum collection and with events at the Castle. She is active in arts organisations in Perthshire and has experience in co-ordinating volunteers and arranging events. Rosemary is Secretary of the Friends Events Committee.

#### **Sarah Riddell-Webster**

Sarah Riddell-Webster was the founder chairwoman of the Friends since they were formed 13 years ago. Sarah is married to a former Black Watch officer so she knows many of the regimental family, both serving and retired. Over the years, Sarah has worked closely with both military families and charities. Sarah is Chairwoman of the Friends Events Committee.

#### **Major (Retd) Ronnie Proctor MBE**

Major Proctor served 40 years as a regular soldier and officer in The Black Watch, including service as RSM and Quartermaster of the 1<sup>st</sup> Battalion and Quartermaster of the 3<sup>rd</sup> Battalion. From 1999 until March 2010 he was The Black Watch Museum Curator; he now holds the post of Honorary Curator and is Military Advisor to the Museum. Major Proctor instigated the life-long learning programme in the Museum; he is also a co-founder and lecturer of the Museum Education Service. Major Proctor is Secretary of The Black Watch Association.

#### **Dr Nicky Small**

Nicky Small is a freelance historian and researcher and was formerly employed as the Perth and Kinross Local History Officer. She has experience of private collections, archives and museum project work, family research, and advising and supporting projects with individuals and organisations. She co-ordinated local project work on the First World War memorial period. She regularly presents on her research and is part of the singer song writing duo PlaidSong. Currently a trustee with the Scottish Local History Forum she is also Chair of the West Stormont Local History Society.

#### **Douglas Walker**

As the CEO, and therefore an ex-officio member, Douglas Walker, has served as a member of the Management Committee over the last year. Douglas comes to the Trust with a wealth of experience, including more than twenty years as a senior manager of Dynamic Earth in Edinburgh where he was latterly Deputy Chief Executive. Douglas has also been a closely involved in hospitality industry trade bodies, including being a past Chair of the Association of Scottish Visitor Attractions (ASVA), Founding Member and past Chair of Unique Venues of Edinburgh (UVA) and a member of the Growth Fund Panel of Visit Scotland.

#### **Major Jamie Erskine**

Joined the Black Watch in 1977 and retired from the Regular Army in 2007. In that time he served in the UK including 6 tours in NI, Germany, Berlin, Cyprus and Gibraltar. On leaving the Army he worked in HQ 2nd Division before becoming the Regimental Secretary of the SCOTS DG in 2011, a job he did until he retired at the end of 2024. He has also been DComdt and then Comdt of the BW Bn ACF and is currently their Honorary Colonel. He is a Trustee of a number of Charities including the Perth Forces Trust.
